- The \$175.00 covers: FOOD FOR THE WEEKEND (EXCEPT WHILE AT DISNEYLAND); HOTEL FOR STUDENTS, DIRECTOR, BUS DRIVERS, AND STAFF; FUEL FOR TOW VEHICLES; 2 BUSES. We have done everything possible to keep the cost down, including special group rates for the hotel through Priceline. Disneyland is also giving us a discount on tickets because we are performing in the park.
- During the trip, we will be stopping for fast food on the way down to L.A., as well as on the way home. Upon exiting the bus, each student will be given \$6.00 to pay for their food. Other meals will be prepared by the boosters, with the exception of 2 meals in Disneyland that need to be covered by the students.
- PLEASE REMEMBER: students will need to pay for 2 meals on Friday, November 13 while at Disneyland.
- All money is due in "the box" by the end of the school day on the dates listed above. If you're taking the money out of your account, please put a signed note in "the box" by the due date.
- Students who pay for the trip but not their Disneyland ticket will be chaperoned at the hotel on Friday while the group performs and has time off at the park.
- Students who do not pay for the trip AND Disneyland will remain in Modesto and attend class on Friday. We will march with holes at the competition. This is not a required trip and payment is not optional. The boosters can not and will not cover the cost for students who don't pay their share.
